**Parent/Guardian Technology Responsible Use Agreement 6th-12th  
Caney Valley 1:1 Instructional Initiative**

I acknowledge that I have reviewed the *Caney Valley 1:1 Initiative Guidebook* and COPPA Parent Agreement which details the initiative’s goals, implementation policies and the care of the Chromebook device itself. I further understand that Caney Valley Public Schools will NOT issue a device to a student until his or her parent or guardian has signed this agreement.

**I understand that my student is expected to**

- Take reasonable steps to ensure that the Chromebook is not damaged or stolen.
- Keep the Chromebook in the case supplied by the District **at all times.**\*
- Leave all CVS labeling in place and in its original condition.
- Bring the Chromebook charged every day.
- Use the Chromebook at school and at home in a responsible manner.

**I understand that I am expected to**

- Ensure my child meets the expectations of the Caney Valley 1:1 Initiative as outlined in the Guidebook.
- Supervise and monitor my child’s use of the Chromebook away from school.
- Pay the cost of repairing or replacing the Chromebook should the device be damaged. The cost of repairs may be mitigated if I choose to participate in the CVS Student Technology Insurance Program.
- If a student leaves Caney Valley Public Schools without returning the Chromebook they will be responsible for the cost of the Device.
- Parents will be financially responsible for lost or stolen devices if insurance is not purchased.

**\*Only Damaged Chromebooks presented in the District-issued case will be covered by the district \$30 insurance policy. Chromebooks presented with signs that the device was not used in the district-issued case, will not be covered by insurance.**
